Thank you for volunteering with the League to Save Lake Tahoe. We greatly appreciate your assistance and commitment to Keep Tahoe Blue. Our insurance policy requires that we have accurate records of all volunteers.

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____ 20____, by _____ (the "Volunteer or Parent/Guardian") in favor of League to Save Lake Tahoe (League), a non-profit corporation, their directors, officers, employees and agents (collectively, "League to Save Lake Tahoe").

The volunteer desires to work as a volunteer for the League and engage in activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include habitat restoration, litter abatement, water quality monitoring, working in the League offices, and/or participating in special events and fundraisers.

The Volunteer hereby freely, voluntarily and without duress executes this Release under the following terms:

Release and Waiver: Volunteer does hereby release and forever discharge and hold harmless the League and its successors and assigns from any and all liability, claims, demands, obligations, costs, expenses, attorney fees, actions and causes of action of whatever kind or nature, wither in law or in equity, which may hereafter arise from Volunteer's Activities with the League. Volunteer understands that this Release discharges the League from any liability or claim that the Volunteer may have against the League with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer's Activities with the League, whether caused by the negligence of the League or its officers, directors, employees, agents, or otherwise. Volunteer also understands that the League does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury or illness.

Medical Treatment: Volunteer does hereby release and forever discharge the League from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment or service rendered in connection with the Volunteer's Activities with the League.

Assumption of the Risk: The Volunteer understands that the activities include work that may be hazardous to the Volunteer including but not limited to habitat restoration, litter abatement and water quality monitoring. Volunteer understands that the specific risks vary from one activity to another, but range from relatively minor injuries such as scratches, bruises, bee stings, allergic reactions, to more serious injuries, including, but not limited to, eye injuries, cuts or gashes, broken bones, loss of limb, paralysis or death.

Volunteer hereby expressly and specifically assumes the risk of injury or harm in the activities and releases the League from all liability for injury, illness, death, or property damage resulting from the activities.

Insurance: The Volunteer understands that, except as otherwise agreed to by the League in writing, the League, does not carry or maintain health, medical, or disability insurance of any Volunteer.

Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release: Volunteer does hereby grant and convey unto the League all rights, title, and interest in any and all photographic images and video or audio recordings made by the League during the Volunteer's Activities with the League including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other: Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. Volunteer agrees that in the event that any clause or provision of this Release shall be held invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
